2. In the Annex II: Terms of Reference, 7. Reports/ 7.1. Reporting requirements – Final report - the following text appears: ” The report shall contain a sufficiently detailed description of the different options to support an informed decision on the realization and multiplication of the 4 movies.” There is no specification in the Documentation, except point 7.1. from Annex II, about the 4 movies. <i>Is this text an error? Can you please help us with more details?</i>	It was an error - please read - In the Annex II: Terms of Reference, 7. Reports/ 7.1. Reporting requirements – Final report - ”The report shall contain a sufficiently detailed description of the different options to support an informed decision on the organization of events as described in Terms of Reference.”
3. The Period of implementation is 6 or 8 month? We are asking because in the Annex II: Terms of reference, point 5.2. Start date & Period of implementation of tasks is specified that ” The intended start date is 16.04.2018 and the period of implementation of the contract will be 6 months from this date.” And in the Special condition – Article 19 Implementation of the tasks and delay is specified ” 19.2 the period for implementing the tasks is 8 months from the start date, but not later than 12.12.2018”.	The period of implementation will be 8 months – but not later than 12.12.2018, as stipulated in Special Condition
