The contract notice is corrected or modified as follow:

Point n°: 4 OF INSTRUCTION TO TENDERS

Instead of - Offers, all correspondence and documents related to the tender exchanged by the tenderer and the Contracting Authority must be written in English.

Supporting documents and printed literature furnished by the tenderer may be in another language, provided they are accompanied by a translation into the language of the procedure. For the purposes of interpreting the tender, the language of the procedure has precedence.

The tender must comprise of a Technical offer and a Financial offer, which must be submitted in separate envelopes (see clause 8). Each Technical offer and Financial offer must contain one original, clearly marked '**Original**', and 1 copies, each marked '**Copy**'. Failure to fulfil the requirements in clauses 4.1, 4.2 and 8 will constitute a formal error and may result in rejection of the tender.

Read - Offers, all correspondence and documents related to the tender exchanged by the tenderer and the Contracting Authority must be written in English.

decision on the realization and multiplication of the 4 movies. The detailed analyses underpinning the recommendations will be presented in annexes to the main report. The final report must be provided along with the corresponding invoice.

Read - Final report with the same specifications as the draft final report, incorporating any comments received from the parties on the draft report. The deadline for sending the final report is 3 days after receipt of comments on the draft final report. The report shall contain a sufficiently detailed description of the different options to support an informed decision on the events organization services. The detailed analyses underpinning the recommendations will be presented in annexes to the main report. The final report must be provided along with the corresponding invoice.

Point n°: 5.2 OF TERMS OF REFERENCE

Start date & Period of implementation of tasks

Instead of The intended start date is 16.04.2018 and the period of implementation of the contract will be 6 months from this date. Please see Articles 19.1 and 19.2 of the Special Conditions for the actual start date and period of implementation.

Read - The intended start date is 16.04.2018 and the period of implementation of the contract will be 8 months from this date, but no later than 12.12.2018. Please see Articles 19.1 and 19.2 of the Special Conditions for the actual start date and period of implementation.

All other terms and conditions of the contract notice remain unchanged. The above alterations and /or corrections to the contract notice are integral part of the contract notice.
