Please clarify which Annexes correspond to each execution phase; For instance, Annex 17 belongs to phase 5 "Island Restoration" or refers to general landscaping works for the entire project and must be quoted in the C+M Execution activity. Annex 25 "Rehabilitation of operational buildings" (object 2.2 design only includes the "DN Access road rebuilding -left bank" (part of object 2.1 design and execution).
- 3. "Memoriu SF Sanmihaiu Roman" in Romanian language, at Phase 2 describes some preliminary works of un-silting the bank deposits and transport to a built deposit. Please indicate the deposit's location and all the works included for its construction.

- 6. Whit regard to the lock rehabilitation, at "Phase 4.1 Hydro-mechanical equipment" execution and installing of two cofferdams size 10x5.3 and their embedded parts (upstream and downstream of lock gates para a) and b)) are described. These cofferdams are not included in its relevant Annex no 28'
 - Please clarify of these two cofferdams are to be quoted and where to be included.

Banat River Basin Administration replied:

- 1. Please use the INFOREURO exchange rate for February 2019.
- 2. Annex 17 refers to island landscape works and must be quoted at C+M activity.

The DN access road rehabilitation (Annex 25) is part of point 2.2. – Rehabilitation of the operational buildings (where only design is foreseen). Not to be confused with rehabilitation road left bank of 235 m, parallel with the lock from stage 3.

- 3. The Beneficiary has the availability of a waste ecological deposit, that can be used for the excavated material. The deposit is at 20 km away from Sinmihaiu Roman.
- 4. According to the Regional Bureau for Cross-border Cooperation decision we are not allowed to provide the requested document. (Addendum no. 1 to the Project)
- 5. Detailed breakdown of the General Estimate for the amount of 4,792,174.78 Euro (excluding VAT).
