The clarification session started at 11.00 h.

From the side of the Contracting Authority, General hospital Pozarevac, Mrs. Milica Jovanović has opened the informative session of the meeting by greeting all participants and explaining that this project is funded from the European Union, though INTERREG IPA Cross-border Cooperation Romania - Serbia Programme. She added that the whole process will be carried out in line with the European standards and EU tender procedures.

Representatives of the Contracting Authority and potential tenderers visited the site for the execution of works. On this occasion, they became acquainted with existing facilities and equipment that will be kept without modifications or reconstructions under this tender, as well as with the location which is intended for the construction of new facilities. At the same time, potential tenderers have learned about the available location for organization of construction site/content

Mrs. Milica Jovanović and Mr. Nikola Todorov thanked the attendees for coming and elaborated on the content and presentation of the Tender, making reference to the published instruction to tenderers. Reference was made to the foreseen timetable, main documents to be delivered in the bidding phase as well as the main selection criteria, validity of the offers, opening of the tender procedures etc.

Finally, it was emphasized that this is just an information meeting and that all the answers which would be given now are exclusively informative, as well as that the official questions and answers will be given in writing. It was explained that the communication for this tender and the documentation will have to be English.

Technical plans and documentation are available to all present representatives.

The official answers to any new questions or those raised during the meeting will be published by the Contracting Authority as specified in the Instructions to Tenderers
