No 1	Selection criteria  Economic and financial capacity of candidate b) The tenderer must have access to sufficient credit and other financial facilities to cover the required cash flow for the duration of the contract. In any case, the amount of credit available must exceed the equivalent of EUR 200.000. The credit amounts in euro must be provided by recognized banks and must be designated specifically for the project. Question 1: Is this required cash flow credit line, must be contained only from available cash flow, or general credit line for guarantees can be the part of this required credit line as well?	Answer  For this selection criteria tenderers need to prove to have access to credit line amounted for at least 200.000 EUR, from which they may finance construction required specifically for this project, without works being dependent from payment dynamics provided by Contracting Authority. Bank need to give written confirmation that funds may be used specifically for this contract. General credit line for guarantees usually
		cannot be used in construction works pre-financing and are not specifically designated for this contract.
