They added that the whole process will be carried out in line with the EU tender procedures.

Tenderers were presented with the mail segments of works to be carried out and with the deadlines.

Potential tenderers can visit the site for the construction work if they want.

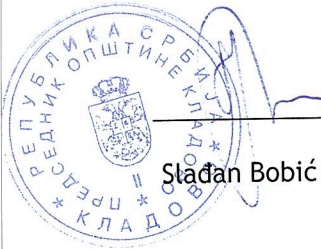
Tenderers were advised to send on official email before deadline for requesting any additional information from the Contracting Authority if the necessary.
