CLARIFICATION 2

According to the Point 8. of the Instruction to tenderers, published in Volume 1 of the launched procurement procedure, ref. no. RORS 373/Cityof Kikinda/TD4, City of Kikinda, as a Contracting Authority, by this Clarification 2 provides answers to all questions duly submitted from publishing date of Clarification 1 (16.08.2021.) up to the date of this document.

Clarification contains 1 question/clarification requests and 1 answer of Contracting Authority. Question is presented in its original text.

QUESTION 1.

1. If the bidder submits a bid with a subcontractor, what proofs must be submitted for the subcontractor?

Note: In Tender documentation (Volume 1, Instruction to Tenderer) we can see next text: „Proof documents, declarations and undertakings according to clauses 3.1-3.6 above. These documents should cover all members of a joint venture/consortium and all subcontractors as specified“, but we can't find clauses 3.1-3.6. Where we can find this clauses?

ANSWER 1.

There is an omission under Point 12.1. of the Instruction to tenderers that question refers. Instead of “Proof documents, declarations and undertakings according to clauses **3.1-3.6** above”, the provision should be: “Proof documents, declarations and undertakings according to clauses **3.1 - 3.4** above.” The omission happened because the provision under Point 12.1 didn't follow necessary adjustment made in Point 3 of the Instruction to Tenderers. The deleted articles from Point 3 - that regulated the Rule of Nationality and Origin - do not apply to the IPA CBC Romania – Serbia Programme any more; by oversight, the mentioned part of the Point 12.1 was left unchanged and didn't follow new numbering from Point 3.

The omission will be corrected through a Corrigendum to the Instructions to Tenderers that will be published in a short notice on Programme web site.



As for the first segment of the Question 1, documents to be submitted for entities included in the tender depends on their role and whether they are capacity-providing entities or not. For further details please refer to: Instruction to Tenderers, Tender form - Section 2, Questionnaire - Section 4 (presented in Volume 1), as well as all other documentation of this tender dossier.
